## COMMUNITY INVESTMENT PROCEDURE

United Way of Payne County ensures donations impact the community where they are needed most. This happens through an extensive community investment process that includes an application, presentation and funding recommendations. This process is administered by the dedicated members of the Community Investment Committee and ensures UWPC remains transparent and accountable with donor contributions.

#### AGENCY APPLICATION & REVIEW — MARCH/APRIL

The Community Investment Committee spends 350+ hours reviewing agency applications, budgets, audits, financial reports, program outcomes, performance histories and presentations.

FUNDING RECOMMENDATIONS — EARLY MAY
The Community Investment Committee discusses funding recommendations for each United Way agency and determines that year's fundraising goal.

**The UWPC Board reviews and approves recommendations or determines any necessary changes.** 

FUNDRAISING — SEPTEMBER - DECEMBER

UWPC and community members raise funds during the annual campaign to be distributed to the agencies in the upcoming year.

Ex. – 2024 pledges support funding for agencies in 2025

FUNDING DISTRIBUTION — JANUARY - DECEMBER

Beginning in January, funds are distributed to each partner agency and continue to be distributed on a monthly basis.

When agencies fill out their community investment application, they indicate which areas their programs serve, which helps us understand how critical needs are being met in Payne County.








#### HOMELESSNESS IN OKLAHOMA OVER TIME


## **IMPACTS** WE MAKE









## **ENDOWMENT**

In 2024, for the first time in United Way of Payne County's 72-year history, an endowment was established with the bequest of a local Stillwater resident.

An endowment is a fund of assets that is invested to provide long-term financial support for a nonprofit organization or cause in perpetuity. Over time this endowment will offer stability and long-term support for our organization and allow United Way of Payne County to extend the impact of donations while opening new doors of opportunity.



#### PLANNED GIVING

Planned giving is a wonderful way to ensure the community we all care about has the ability to continue to address the needs of its residents and is a rewarding way to make a lasting impact. A Planned Gift is any donation made as part of an individual's overall financial and/or estate planning. Planned Giving allows individuals to meet personal, financial, and philanthropic goals in tax-efficient, estate-friendly ways.

#### **BEQUEST**

One of the most popular and flexible ways to make a significant gift to United Way is through a bequest. A bequest is a gift of property, assets, or a portion of an estate made through a will, living trust or codicil. There are multiple ways to make a bequest to United Way from a specific, percentage, residual, or contingent bequest.

#### RETIREMENT PLAN DESIGNATION

A retirement plan designation is another form of Planned Giving done by donating part or all of unused retirement assets, such as your IRA, 401(k), 403(b), pension or other tax-deferred plan to United Way. Assets given to United Way are not taxed, while 40%-60% of retirement assets may be taxed if left to heirs.

United Way offers a free, easy way to create a will or revocable living trust at no cost. By teaming up with FreeWill, individuals have access to planning tools that are easy to use, intuitive and free. Most individuals are able to create these important documents in 20 minutes. Whether the will includes a gift to United Way or not, the tool is completely free to users.


#### VARSITY REVUE



### BENNETT BASORE AWARD

United Way of Payne County established the Bennett Basore Award in 2002. This award honors Bennett Basore and his leadership in establishing the local United Way accreditation procedure to insure accountability to donors and proper utilization of funds. The winning agency receives a \$1,000 stipend and recognition.

#### **BIG BROTHERS BIG SISTERS**

Big Brothers Big Sisters showed outstanding work in our community through proper utilization of funds and compliance with state, federal and United Way regulations.







Big Brothers Big Sisters of Oklahoma creates meaningful, monitored mentoring relationships between adult volunteers (Bigs) and children (Littles) in the Stillwater area.

- In 2024, BBBS achieved **28% growth** in quality volunteer Big enrollment and therefore the ability to take more children off their waiting list and provide them with mentoring.
- ➤ The five Big Brothers Big Sisters of Oklahoma locations were collectively awarded Large Agency of the Year by Big Brothers Big Sisters of America, standing out among other large agencies across the U.S.

## DAY OF CARING 2024

Day of Caring marks the beginning of the five-month United Way campaign that raises vital funds for Payne County. UWPC organizes residents to participate in this community service event that brings together more than 750 volunteers on a single day to perform 100+ service projects across Payne County. These projects support United Way partner agencies and clients they serve, improve and beautify public spaces, and generate a sense of camaraderie and connection among participants.


DAY OF CARING PROJECT SITES
